### Issue:

Award of contract for bid ITB #2024-001: Full Depth Reclamation and Resurfacing

## **Recommendation:**

Staff recommendation is to award the contract to Georgia Paving, Inc for \$3,081,853.00.

## Background:

Due to the rapid deterioration of some of our subdivision streets, staff prepared a list of streets, which 36 of the streets, are recommended for treatment. Some of these will require full depth reclamation where the existing asphalt and base is milled up, and soil cement base is installed, and the road is repaved. Other streets will require milling, patching, and resurfacing.
